This standard effectively will result in most board meetings being held virtually or with significant modifications to in-person attendance limits and meeting protocols.

A new disaster proclamation will result in more virtual board of education meetings. In accordance with recent revisions to the Open Meetings Act in <u>P.A. 101-640</u>, during periods in which a public health disaster declaration is in effect, boards of education may hold meetings virtually when a physical quorum is not practical or prudent and may restrict attendance.
